This year we see many solar powered camps in the market. *Sanctuary Chief's Camp* will use 100% renewable energy sources from the solar farm on the camp.

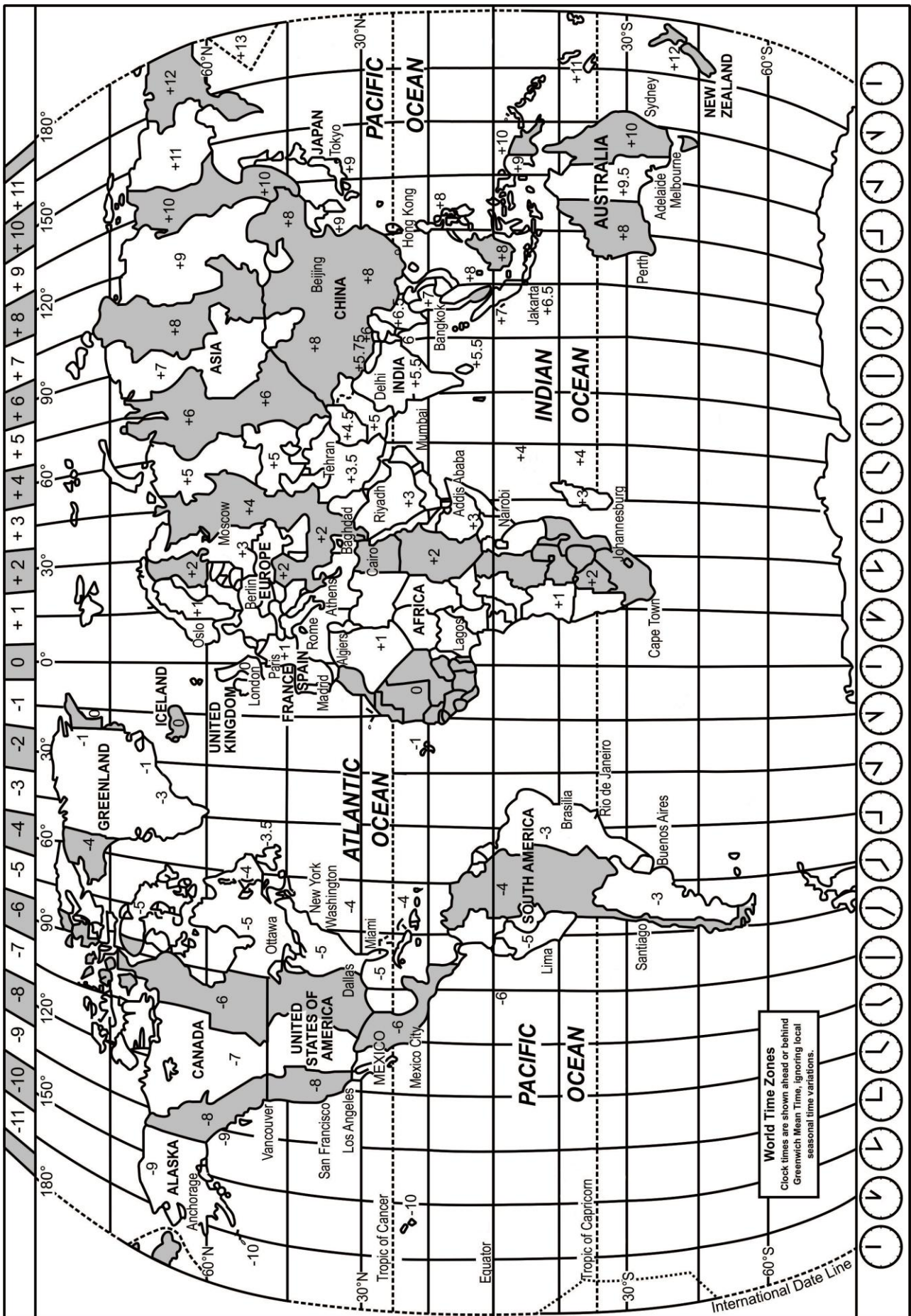
The solar camps help reduce any negative impacts on the environment. Their sewage purity system reduces contamination.

ADDENDUM D: Cyclone Dineo hits Mozambique, puts Kruger and KZN on high alert**Cyclone Dineo hits Mozambique, puts Kruger and KZN on high alert**

The Kruger National Park as well as the Province of KwaZulu-Natal has alerted its disaster management teams for storms and floods as Cyclone Dineo strengthens and is expected to bring heavy rainfall to Limpopo and KZN over the weekend.

It is expected to bring wind speeds of about 166 km/h, as well as severe rain that could bring flooding. The coastline will be especially exposed to storm surge.

William Mabasa from the Kruger National Park says, "The cyclone will possibly hit the whole park. Visitors who are in the Park on Friday and Saturday must take safety measures and stay in the camps if it rains. Those who may somehow be trapped out, will need to call or send whatever communication to our Emergency centre".

Heavy rain over the southern parts of the Kruger National Park has caused many of the gravel roads to close. Never drive, ride or walk in floodwaters. Fill buckets, sinks and baths with water in case the water supply becomes limited.
